## 1. Baseball Law

Generally a team is not responsible to a spectator struck by a batted ball, but here, such a victim won the right to a trial because the team could not show that there was no reasonable action it could have taken to minimize the risk of injury from foul balls.

# 2. Tenants' Rights

Tenant relocation fees imposed by some cities are not unconstitutional, but are allowable as a reasonable state regulation of the landlord-tenant relationship.

## 3. Deeds

Having been physically delivered to the transferee, a deed took effect at once and was valid even without the satisfaction of certain oral conditions.

#### 4. Lease Enforcement

Whenever feasible, a right of first refusal contained in a lease to purchase the rented property must be interpreted as effective if the terms can be carried out without violating the intention of the parties.

#### 5. Escrow Law

Where a landowner tried to back out of a contract to sell land, the buyer is entitled to specific performance as well as damages because the seller unreasonably delayed the release of the buyer's escrow deposit.

## 6. Successor in Interest

A land developer contracted with a county to pay certain fees for the right to build a subdivision. After the owner sold the property to another developer, the buyer refused to pay the fees, Sieff Newsletter June 2022 Page 2

but the court ruled it had to because the seller's contract was a "lien" against the property which bound the successor.

## 7. Environmental Law

In deciding whether to require an environmental impact report in advance of approving a land-use modification, a court can consider factual statements of members of the public as substantial evidence.
