# 1. Oscars

The contractual right of the Academy to purchase Oscar statuettes for \$10 supersedes the rights of the creditors of award recipients.

# 2. Covid

Business losses resulting from government prohibitions of restaurant operations were properly excluded from a business interruption policy.

## 3. Settlements

If a litigant rejects a pre-trial offer for a specific sum and eventually agrees to accept a lesser amount, it can be held responsible for the legal expenses of the other party following the rejection.

#### 4. Contracts

A new worker required to sign a promise to arbitrate future disputes as a condition of being hired is bound to the agreement even though it was presented as a "take it or leave it" proposition.

#### 5. Non-Profits

After a local charity disaffiliated from a national organization, decedents bequeathed funds to the local which was not required to share the proceeds with the national.

## 7. E-Scooters

A company rents battery-operated scooters which customers retrieve from public locations and abandon at their destinations. Because the company agrees with local jurisdictions to ensure vehicles do not become trip hazards, a pedestrian injured after falling over an abandoned scooter can recover damages for personal injury.

# 8. Facebook

What happens when an account holder dies? Facebook allows members to designate a "legacy contact" to update status, manage tributes, restrict access, close accounts, and respond to post mortem communications, but not to impersonate the member.
